A position (PCN 07-1003), a Special Assistant to the Commissioner II, deleted by the Legislature along with the position's funding is being retained. The position will act as the Commissioner's Special Assistant for Workforce Development. With the Executive Branch Reorganization bill (HB 40) the department now has two divisions primarily dedicated to workforce development, the Employment Security Division & the Division of Vocational Rehabilitation. These two divisions have a combined total of 583 of the departments 841 employees and \$93.7 million of the departments \$118.5 million budget.												
In addition, five boards, the State Independent Living Council, Community Service Board, HRIC, Governor's Committee on Employment of People with Disabilities and the Statewide Private Industry Council have been added to the department which while housed in divisions will require either a Commissioner designee's participation and/or direct liaison with the Commissioner's Office.												
No staff have been added to the Commissioner's Office to deal with the workload increase caused by the consolidation of programs. As a result the department is unable to reduce staffing in the Commissioner's Office at this time.												
Funding for the position in FY 2000 will be by unbudgeted inter-agency receipts, budgeted funding will be added to our FY 2001 budget request. The inter-agency receipts will be received from the federal programs being supported. Due to the use of unbudgeted receipts in FY 2000 the Commissioner's Office component shows an 18.9% vacancy factor. After adjusting for the unbudgeted funding the vacancy factor is 1.6% which is within OMB guidelines.

This is a request to establish 8 additional Employment Security IB positions in the Juneau Unemployment Insurance call centers (07-#046, 07-#047, 07-#048, 07-#049, 07-#050, 07-#060, 07-#061, and 07-#062). Over the last four annual budget cycles, there was a major effort to more realistically reflect the needed level of positions necessary to operate the programs in the Employment Security Division, particularly in the Unemployment Insurance Program. Across all division budget components, ESD has deleted approximately 106 positions since FY95. Due to changes and reorganization of UI operations at that time, the division found they had an excess of budgeted positions. There was a significant reduction applied to the number of positions in the UI budget component. While this has had a number of benefits, we have reached the level that filling virtually any vacancy requires a level of creativity in switching positions from cost center to cost center and reclassifying as necessary. It has recently become necessary to "double-fill" positions in the UI Call Centers for extended periods of time in order to hire replacements far enough in advance of announced retirements to allow sufficient training time. The standard training period for new claims processing staff is three months of classroom training followed by three months of closely mentored "OJT."

Claims processing staff are closely funded through the UI grant, contingent on claims load. An increase in the statewide average unemployment rate from this year's 5.9% to just 6.9% would represent an increase in claims workload of over 15%. This would require the hiring of 10-15 more front line staff (ESS IA/B's) just to keep current with the workload increase.

These positions will be filled only as needed to promptly respond to an increase in unemployment claims activity at which time they would be funded by automatic workload driven increases in the UI grant.

A line item transfer to personal services is necessary to adequately fund the adjustments and additions reflected in the other change records. Contractual services is reduced in the data processing professional services area due to the passage of the capital budget for UI tax redesign. The costs in the operating budget are expected to be reduced as a result.
