During FY 2000 the Department of Health and Social Services received an appropriation in Chapter 2 FSSLA 99 a portion of which will be passed through to the Department of Law in the form of an unbudgeted RSA. This RSA will fund two new attorneys to assist with the "Balloon Project". This effort addresses the backlog of Alaskan children who have not yet been placed in permanent homes and have exceeded the amount of time the law allows for such placement in accordance with HB 375, Chapter 99, SLA 98. Comparable federal requirements are embodied in what is known as the Adoption and Safe Families Act.

2. The Juvenile Accountability Incentive Block Grant was awarded to the Department of Health and Social Services during FY 99 as a result of a revised program approved by the Legislative Budget and Audit Committee.
