Project Description/Justification:

As authorized December 12, 1980 by 42 U.S.C. Chapter 78, Sections 6501-6508, the Federal Government, through the U.S. Department of the Interior, Bureau of Land Management (BLM) allows for the exploration and development of oil and gas within the National Petroleum Reserve-Alaska (NPRA).

Though the federal government manages the NPRA, Section 6508 of the federal statute requires that fifty-percent of the money received by the federal government from the "sales, rentals, bonuses, and royalties on leases issued..." be paid to the State of Alaska. Leases awarded by the federal government are usually for ten years and require that each company holding a lease pay an annual amount which decreases each year.

In accordance with Section 6508, the monies are to be used by "the State of Alaska for (a) planning, (b) construction, maintenance, and operation of essential public facilities, and (c) other necessary provisions of public service: *Provided further*, That in the allocation of such funds, the State shall give priority to use by subdivisions of the State most directly or severely impacted by development of oil and gas leased under this section."

In accordance with federal statute, the Alaska Legislature enacted AS 37.05.530(c) through (e), establishing the NPRA Impact Grant Program within the Department of Community and Economic Development (DCED) whereby communities may apply for assistance, i.e., grants to fund projects that fall within the federal and state guidelines. As required, priority is given to those communities directly or severely impacted by oil and gas development.

DCED is anticipating \$1,680,000 from the 1999 leases and \$33,600,000 from the most recent June 2002 leases. The total is approximately \$35,300,000. The application process for NPRA monies anticipated in FY04 has been completed. There are 20 projects in two communities/boroughs that have been tentatively approved. They are:

AS 37.05.530(g) provides that any funds received that are not appropriated as impact grants to the municipalities are deposited as follows: 25% to the principal of the Alaska Permanent Fund and .5% to the public school trust fund. The amount remaining may be appropriated to the power cost equalization and rural electric capitalization fund (AS 42.45.100). As result, it is estimated that approximately \$10,270,500 may be distributed as follows:

- 1) Alaska Permanent Fund Principal: \$2,567,600
- 2) Public School Trust Fund: \$51,400
- 3) PCE Fund: \$7,651,500
