**Project Description/Justification:**

Currently, there is no dock facility in Perryville. Fuel and freight barge landings can be difficult with poor weather conditions. The project will provide roll-on/roll-off barge facilities and "dolphins" for a barge to tie off to, as well as a small dock to handle other boats needing to load fuel or freight.

This project will provide a safe, reliable and economic transfer of fuel and freight for Perryville. The engineering and design of this project will also be used for similar projects in the Iliamma villages (pending project funding).

Partners in the project include the Village of Perryville, the Lake and Peninsula Borough and the Denali Commission. The estimated cost is between \$1.5 to \$3.5 million for Perryville's facility, pending design recommendations. The Lake and Peninsula Borough will work with Perryville to help acquire necessary tidelands and/or uplands deemed necessary for the project. The Denali Commission has identified \$160,125 for this project to perform design, permitting and environmental review. \$100,000 is requested to match the Denali Commission funding.
