Project Description/Justification:

The purpose of the Imaging portion of this project is to supplement the Imaging project by 'mirroring' the process we are establishing in our Juneau office in our Anchorage office. This will benefit the division by reducing the amount of network traffic sending large images back and forth across the wires (very slow). Also for disaster recovery purposes - if we ever had an outage in either location, the other location would be able to pick up all the load of the missing element. It would be more efficient to be able to process documents in both locations. That way we won't have to ship documents to Juneau for imaging – the process will exist in Anchorage.

The purpose of the Re-engineering Business Processes (Pheonix) web development phase is to make it flexible enough to work with all internet browsers.

The Other Insurance Needs portion of this project breaks down into general areas of need in the division. One need is to upgrade the air conditioner in the computer room. The existing equipment is over 15 years old and routinely stops working or floods the computer room – and also the Alaska State Library below it. The Division is also embarking upon a re-write of its applications, and we are moving away from Oracle Forms and Reports into VB.Net. We need three servers to move forward on this project. We are also requesting funds to purchase two color printers for the Division, one in Anchorage and one in Juneau. We also need to purchase three laptops for the Information Technology staff.
