Core Services

- Administer 20 professional and occupational licensing programs through support to Boards or Commissions; administer 17 professional and occupational licensing programs solely through the division (without oversight of a board or commission).
- License businesses to engage in commerce in Alaska, and grant tobacco endorsements for the sale of tobacco or tobacco related products.
- Register Corporations engaged in commerce in Alaska.
- investigate and resolve consumer complaints about state licensees and regulated and licensed businesses.
- Provide investigative services to professional licensing boards and commissions.
- Investigate complaints concerning state licensed non-depository financial institutions and money service companies.
- Provide consumer outreach and education on the use of professionals, and non-depository lending.
