**Additional Information / Prior Funding History:****Project Description/Justification:**

\$350.0 Elevator Repair / Replacement

The kitchen food delivery elevator was installed during the 1966 construction. The elevator is currently out of compliance with ADA Code and is subject to catastrophic failure. Elevator repair/replacement is necessary to reduce the risk of injury and maintain current food service operations.

\$250.0 Underground Fuel System Replacement

Replacement of single wall Underground Storage Tank (UST) and fuel lines per LOA with DEC. Single wall tank and lines at risk for leakage without repairs.

\$500.0 Place-holder Project - Unit III Security Lock Upgrades (If any funds are available.)

Replace minimum security locks with maximum security locks. In 1986 this unit was constructed as a minimum security housing unit. Due to overcrowding the department must now house "Close Custody" level of inmates in this unit. Safety and security standards require that the security level be upgraded for staff and inmate safety.
