**Project Description/Justification:**

- Statewide fish passages, counting & sampling sites, or weir facilities - \$250,000
- Statewide warehouse/workshop facilities - \$250,000
- Statewide small field site/camp facilities - \$150,000

Priorities and cost estimates may need to be adjusted to accommodate emergency maintenance projects not listed, actual project costs, and other considerations.
