<p>This increment is to provide additional funding for youth in detention facilities and youth in adult corrections. Currently, \$800.0 is budgeted that supports the educational programs at the Johnson, McLaughlin, Fairbanks and Bethel Youth Facilities. These students are counted in the foundation program and served by the school district in those communities. The foundation funding is not sufficient to provide the year round services to these students and the Youth in Detention grant funds help to cover that cost. Recent expansion at Johnson and McLaughlin have resulted in increased costs to provide services and additional youth facilities in Ketchikan, Nome, and Mat-Su will come on line in FY2000. Approximately 258 students were served last year.</p> <p>Education & Early Development is working with the Department of Corrections to set up a mechanism to provide services to approximately 250 youth in adult correction facilities. Currently those students are not counted in the foundation program. Some of these youth may be served through adult basic education GED programs.</p> <p>Although there are currently 344 inmates under age 22 in adult corrections, some of these youth may refuse services and some will choose a GED program.</p> <p>This increment request targets services to youth in adult corrections and youth in detention facilities between 16 and 19 years old.</p>
