The FY2000 federal grant for the Alaska Coastal Management Program (ACMP) was \$82.7 greater than anticipated. A FY2000 RPL for increased federal receipt authority was requested in December 1999 to allow expenditure of this higher federal grant award amount. The FY2001 ACMP federal grant award is expected to be the same as that received in FY2000. Therefore, this increment increases the component's federal receipt authority by \$82.7. No increase in state matching funds is required for this increased federal funding.

Beginning in July 1999, the federal government extended the grant period for the Section 309/310 Enhancement Grant portion of the ACMP grant. The scope and complexity of Section 309/310 Enhancement projects has increased over time requiring a longer project period. In FY1999 approximately \$133.1 in federal authority lapsed due to ongoing and uncompleted Section 309/310 projects. In order to complete these projects, a FY2000 RPL for \$133.1 in increased federal receipt authority was requested in December 1999. To minimize the annual request for increased federal authority through the LB&A process, an increment for \$200.0 of federal authority is requested in FY2001. This increment represents approximately one-third of the FY2000 Enhancement Grant award to the State of Alaska of \$605.2.

The expenditure line items are estimated to be in the same proportion as the project costs that were carried forward from the FY1999 Enhancement Grant projects, which was the basis for the FY2000 RPL request. Personal service expenditures will fund three temporary project positions. This increment adds a
