Additional Information / Prior Funding History:

In SLA 00 \$100,000 was appropriated from AMHTAAR for this program. In SLA 97, \$60,000 was appropriated, though a revised program legislative, from AMHTAAR for grant for a Spirit Camp at Minto.

Project Description/Justification:**Project Description:**

This request enables the Department to replicate culturally based family alcohol and drug abuse treatment similar to the Old Minto Spirit Camp. These funds will be used to develop two new summer camps in Western Alaska, Southwest Alaska, the Interior, the Northern Region or Southeast Alaska. These facilities are offered in a remote location and offer treatment with culturally appropriate activities.

Capital funds will be allocated through the Request for Proposals process, in conjunction with operating funds, to provide the basic health and safety needs (shelters for sleeping and meeting, stoves for warmth and cooking, and latrine facilities). This includes replacing broken windows, installing stoves in existing cabins and structures, building tent platforms and/or purchasing canvas tents. Many programs (grantees) will not be able to provide treatment without the capital funds to repair/upgrade lodging for participants.

The number of recovery camps receiving funds will be between two and four. The Division of Alcoholism and Drug Abuse prefers that recovery camps operate for at least 30 days. Some grantees, however, may operate longer or may have a larger number of participants than others, thus requiring more funds. Grantees could need as much as \$50,000 or as little as \$10,000.

We will seek competitive proposals. We are looking for recovery camps that follow the Old Minto model but will allow flexibility for regional and cultural appropriateness.
