Additional Information / Prior Funding History:

The Western Identification Network (WIN) has obtained pilot funding through a grant awarded by the United States Department of Commerce, National Telecommunications and Information Administration, Telecommunications and Information Infrastructure Assistance Program (TIIAP). WIN is using these grant funds and matching funds from corporate resources to provide access to photo databases in California, Oregon and the central WIN site.

Project Description/Justification:

FEDERAL FUNDING AGENCY: United States Department of Justice, Office of Justice Programs.

PARTNERING ORGANIZATIONS Department of Public Safety, Department of Corrections, Department of Administration, Local Police Departments, Western Identification Network, Western States (Alaska, Washington, Oregon, Idaho, California, Nevada, Montana, Wyoming, Utah)

PREVIOUS FUNDING HISTORY: The Western Identification Network (WIN) has obtained pilot funding through a grant awarded by the United States Department of Commerce, National Telecommunications and Information Administration, Telecommunications and Information Infrastructure Assistance Program (TIIAP). WIN is using these grant funds and matching funds from corporate resources to provide access to photo databases in California, Oregon and the central WIN site. Photo capture and retrieval stations are being deployed region wide on a pilot basis. Locations currently being served include 6th Avenue Corrections Center, Anchorage and the Anchorage Police Department. The State of Alaska has not received any direct funding for this project.

PROBLEM ADDRESSED BY PROJECT: Law enforcement requires critical person identification information in daily conduct of its work e.g. fingerprints, photographs and DNA. This project would directly provide access to Alaska booking, driver and ID photographic information throughout the state.

DESCRIPTION OF PROJECT, INCLUDING WHO WOULD BENEFIT AND LONG-TERM IMPACTS: This project would provide photo capture equipment to all correctional facilities, establish a central computer database of these photographs now manually maintained by the Criminal Records Bureau and provide photo retrieval workstations at major police locations.

The Department of Public Safety will centrally administer this grant funding and coordinate with Corrections, Troopers, local police and Department of Administration - ITG regarding deployment of mugshot capture at adult booking locations and implement the ability to retrieve these photos by authorized law enforcement users.

DURATION OF PROJECT (SINGLE YEAR OR MULTI-YEAR): This will provide the one time funding to deploy the system.

HAVE SIMILAR PROJECTS/PROGRAMS BEEN FUNDED PREVIOUSLY IN OTHER STATES? Yes. The Western Identification Network, Orange County California and other western state jurisdictions.

IS STATE MATCH REQUIRED/EXPECTED? This request is for a federal earmark. No match is anticipated.

TIMING ISSUE: The Department of Public Safety was notified of the federal appropriation after the Governor's 2002 capital budget was released requiring that this project be submitted as an amendment to the original request.
