Supplemental Housing Development Program utilizes Corporate (AHFC) funds to supplement Federal (HUD) funds to construct decent, safe and sanitary housing through regional housing authorities established under AS 18.55.996. Funds are used to cover housing development costs related to water distribution, sewer hookups, electrical distribution systems, road construction to project site, site development, and energy efficiency improvements. State laws limits the use of these funds to 20% of the HUD's total development cost per unit, and are prohibited from being used for administrative or other costs of the housing authority.

**Project Description/Justification:**

**The purpose of the program** is to supplement federal housing funds provided to Regional Housing Authorities to ensure safe, decent, affordable housing throughout Alaska.

**The projected outcomes are:**

- Construction of 320 affordable homes in 20 urban and rural communities for 320 families
- On-site water and sewer facilities
- Roads to project sites
- Electrical distribution systems
- Energy-efficient design features in homes
- Leverage \$4.0 million in Indian Health Service/Public Health funds for offsite water and sewer facilities

AHFC is limited by State statute to contributing 20% of HUD's Total Development Cost (TDC) of a project.

Funds are used for on-site water and sewer facilities, roads to project sites, electrical distribution systems, and energy-efficient design features in homes constructed by the regional housing authorities. HUD regulations prohibit the use of

development funds for construction of access roads, electrical distribution systems and certain other infrastructure costs.

Since its inception, the state has appropriated more than \$100 million to augment over \$500 million in HUD funds and \$50 million in Public Health Services funds to build a total of 6,373 houses in 250 communities.

Supplemental Housing Grant funds reinvests funds into communities by creating 300 local jobs statewide, creating nearly 100 training and apprenticeship opportunities in local labor pools, and purchase of supplies from local vendors.
