**Brief Summary and Statement of Need:**

All facilities with a fuel tank over 660 gallon capacity, or total combined capacity over 1320 gallons, require a Spill Prevention Control and Countermeasures (SPCC) plan under the Clean Water Act. The SPCC plans must be reviewed and updated every 3 years by a licensed engineer. State and Military Facilities are not exempt under this Act.
