**Additional Information / Prior Funding History:**

The National Fire Plan is funded by congress on an annual basis. It is anticipated that this level of funding will gradually increase for several budget cycles and then eventually be eliminated. At this time it is anticipated that the additional federal grant funds will increase in a phased manner for three years.

**Project Description/Justification:**

**Detailed Project Justification:**

This project will enable the Division to meet its responsibilities of providing wildland fire protection services on state, private, and municipal lands as mandated in AS.41.15.010 – 170. These funds will allow the Division to improve and enhance its abilities to protect the citizens and resources of Alaska. The threat of catastrophic wildland fires in the urban interface areas in the state is increasing as the citizens of Alaska continue to move into the forested areas of the state. The additional federal grant funds will be utilized for the following projects:

- Improvement of the Division's initial attack and extended attack capabilities.
- Improvement of local government and volunteer fire department capabilities to respond to structure and wildland fire incidents in the urban interface areas of the state.
- Provide funding for and EFF type 1 hotshot crew to be utilized in Alaska and the lower 48 to aid in the suppression of wildland fires.

**Specific Spending Detail:**

71000 – (\$500.0) Personal services for EFF hotshot crewmembers, extension of permanent seasonal fire positions.

72000 – (\$100.0) Travel and per diem costs for state and local government personnel to travel to present and receive specialized fire training.

73000 – (\$100.0) Contractual services funding to facilitate intermediate and advanced Incident Command System (ICS) training and specialized fire training

74000 – (\$500.0) Purchase of specialized firefighting equipment for use by the Division's firefighters and local government and volunteer fire departments.

**State Match Required:**

There is a 50% match of State funds to receive these federal grant funds. The match requirement will be met by in-kind general funds already obligated to the Division's Fire & Aviation Program.

**Project Support:**

Broad support is anticipated from the general public, local government, volunteer fire departments, and numerous state and federal government cooperating agencies.

No opposition is anticipated for this request.
