Chapter 61 SLA 2001 Page 10 Line 8 \$600,000 General Funds; Chapter 135 SLA 2000 \$600,000 AHFC; Chapter 2 FSSLA 1999 \$800,000 GF; Chapter 139 SLA 1998 \$800,000 GF; Chapter 100 SLA 1997 \$900,000 GF.

Project Description/Justification:

The Department is responsible for maintaining 112 state-owned buildings (over 1.1 million square feet and \$372.5 million in replacement value). A majority of these buildings are over 20 years old and 10% exceeding 40 years of age.

The repair and replacement requirements are necessary to insure that the facilities will continue to operate safely. Following a national standard adopted by all Alaska state agencies for estimating annual renewal and replacement requirements (Annual Renewal Requirements = 75% X Current Replacement Value X Age of Building / 1275), the Department needs approximately \$4.0 million in annual funding to properly maintain the existing facilities. The amount in this budget request does not meet the national standard, however, it will address the most essential work that must be accomplished this fiscal year.

The renovation and remodeling requirements are necessary to meet safety, security and medical needs. The Department anticipates that roughly 20% of this funding will be used for emergency work that occurs annually throughout the Agency.

Funding appropriated for this request will be allocated towards addressing as much of the following critical facility capital projects as possible:
