The Department of Law implemented a reclassification of its legal support positions in the final pay period of FY 2001. The study was undertaken for a number of reasons: primarily because recruitment of legal secretaries was becoming increasingly difficult and retention was increasingly problematic - 46% of legal secretary positions turned over in FY 2000; additionally the class specifications for these positions had last been reviewed in 1969, finally, the State had undertaken a study of the Secretary I&II positions in 1998 and collapsed them into the upper range of 11 - while Legal Secretary I's remained at range 10 (this latter set of circumstances resulted in a union grievance against the state). The Legal Secretary study commenced in February of 2000 and was completed in the late spring of FY 2001 and approved by the Division of Personnel in June. The reclassification called for higher salary ranges for nearly all positions involved in the study. All Criminal Division components were affected by the implementation of this study, and as a result, this budget request includes an increment for this purpose in each component. Without funding for each of these related increments, the Department will be forced to eliminate positions.

<p>During the next year, there will be many federal telecommunications matters that are important to Alaska and on which the State will need experienced telecommunications counsel. The State has had outside counsel providing legal services in this area for many years. Formerly, funding for the contract with outside counsel to perform this work was provided through a reimbursable service agreement with the Governor's Office. Due to the reduction in amount of funding available from the Governor's Office, \$120,000 in general funds to continue this important work are requested by the Department of Law. Since the passage of the Telecommunications Act of 1996, the focus has been on seeking to assure that the implementation of that Act by the Federal Communications Commission advances the interests of the people of Alaska. Of consequence in FY 2003 is the protection and possible expansion of the policies of "geographic rate averaging" and "rate integration." These policies assure that Alaskans do not pay more for interstate long distance services than other Americans. These policies are under continuous attack from long distance carriers who want the opportunity to charge prices that reflect costs in each area they serve. Such an approach would result in higher prices for Alaskans, particularly in rural areas of the State. One particular issue likely to arise in FY 2003 is the application of these policies to cellular services. Additionally, outside counsel is in the early stages of a process that will continue in FY 2003 to try to obtain support for local or toll-free dial-up Internet access services, which are currently not available in the vast majority of rural Alaskan communities. Other approaches are currently sought to address this problem, including seeking a waiver from FCC rules to permit local school districts to share their facilities or services funded by the universal service program to provide Internet access to community members when schools are closed. In addition to providing specialized legal counsel and advice on proposed telecommunications legislation and new rulemakings and petitions filed at the FCC, there are many other telecommunications issues that arise on an emergency basis each year and cannot be predicted with specificity.</p>
