Project Description/Justification:

Specific federally-funded programs:

1. Alaska's Floodplain and Erosion Management Program: This program's mission is to reduce public and private sector damage and losses from flooding and erosion. This is accomplished by providing communities that participate in the National Flood Insurance Program (NFIP) with technical assistance and grants for the initial planning and subsequent construction of flood mitigation projects.

DCED and the Federal Emergency Management Agency's (FEMA) Flood Mitigation Assistance Program (FMAP) personnel are actively working with the communities on every phase of a potential project -- applying for a planning grant, approving the resulting plan, approving a construction grant, approving a completed project.

This program has existed since 1997. From FY2000 through FY2003 the average total funding was \$400,000, with FEMA providing \$300,000 and requiring \$100,000 (25 percent match) from the State. In FY2004, DCED's application to FEMA requesting federal funding was denied -- of all 50 states, FEMA selected only 5 states.

DCED will again submit an application to FEMA for the funding of this program in FY2005 and anticipates \$300,000 in federal funding with a State match requirement of \$100,000.

2. Mini-Grants: This program provides grants to rural communities for projects that develop, expand, and/or diversify a community's economy. Typical projects are the development of a community economic plan or strategy; feasibility studies for infrastructure projects; design and engineering studies; business plans for community cooperatives; upgrades

to tourism infrastructure such as recreational vehicle facilities; and upgrades to marine facilities and/or educational facilities.

The program has existed since the mid 1980's. From FY2000 through FY2004 the average total funding from the U.S. Department of Agriculture (USDA) has been between \$200,000 to \$250,000 and requiring a \$50,000 (20 percent match) from the State. Also, since FY2000 the federal agency Denali Commission (DC) has provided an additional \$500,000 and requires no State match.

For FY2005 DCED anticipates \$300,000 in federal funding from the USDA with an Alaska Student Loan Corporation Bond match requirement of \$75,000 and an additional \$500,000 from the Denali Commission requiring no State match.

3. Multi-Use Facilities Grants: Established in FY2004 this program provides grants to communities for the construction and/or remodeling of multi-use facilities in ten rural Alaska communities. The program's total funding of \$7,677,032 was provided by the federal Denali Commission (DC) (approved through an RPL). Though no State match is required, communities are required to contribute 10 to 25 percent of the cost of a project. For FY2005 DCED anticipates \$7,800,000 in federal funding. A State match will not be required.

The Multi-Use Facilities Grants replaces the Communities Priorities Grants program that was established in FY2002 and that provided grants for community infrastructure projects. In fiscal year 2003 the federal Denali Commission (DC) provided \$2,200,000 in federal funding. Though anticipated for FY2004, the program was deleted and the Multi-Use Facilities Grant program was increased.

4. Accelerated Infrastructure Development Grants: Established in FY2003, this program provides funding for the development of community profile maps for unmapped communities. Communities within the Aleutians East Borough and the Lake and Peninsula Borough are currently eligible and other eligible regions will be identified throughout FY2004.

Since its inception, the programs annual funding has been \$300,000 provided in total by the federal Denali Commission (DC). For FY2005 DCED anticipates \$300,000 in federal funding. A State match will not be required.

5. Constructing Palmer Hospital Water and Sewer Utilities: Pass through grant to the City of Palmer for up to 75% of the cost of constructing water and sewer utilities for the new hospital being built in Palmer. USDA personnel located in Palmer will work with the City of Palmer personnel in managing the project, preparing progress and financial reports and submitting the information to USDA. For FY2005 DCED anticipates \$7,000,000 in federal funding. The City of Palmer is responsible for the remaining 25% of funding.

6. Delta Junction Missile Defense Impact: Pass through grants to the City of Delta Junction and the Delta Junction school district intended to mitigate the impact of the construction and operation of the Missile Defense Test Bed Facilities at Fort Greely.

The U.S. Department of Defense (DOD) is currently providing \$18,300,000 in funding to DCED which is being passed through to Delta Junction. For FY05 DCED anticipates an additional \$10,000,000 in federal funding. A State match will not be required.
