Construct transient air parking, general aviation parking, access roads, heliport pad, aviation support areas and obstruction removal. Expand existing apron area, drainage improvements and construct partial parallel and connecting taxiways. Complete other improvements as funding allows. This project contributes to the Department's Mission by reducing injuries, fatalities and property damage, by improving the mobility of people and goods and by increasing private investment.

**Project Description/Justification:**

The Cordova Master Plan Update has identified several projects needed in the near term to address leasing development, access and aircraft separation issues at the airport. Currently cars and aircraft share taxiway D. There is limited area and access for transient and GA aircraft parking and helicopters operate in the same area as small aircraft. A partial parallel taxiway will be constructed from taxiway "B" to a new taxiway "E" to better accommodate jet turnaround and access to the apron without "back-taxiing" on the main runway. The project estimate increase resulted from combining this project with the Cordova Blast Pad and Obstruction Removal project, and rising construction costs.
