**Brief Summary and Statement of Need:**

Resurface widened and improved roadway with a final lift of hot asphalt pavement; install traffic markings; replace sidewalks, drainage improvements, and upgrade lighting. This project contributes to the Department's Mission by reducing injuries, fatalities and property damage and by improving the mobility of people and goods.

**Additional Information / Prior Funding History:**

FY2005 - \$1,300,000; FY2003 - \$1,330,000; FY2000 - \$570,000.

**Project Description/Justification:**

This allocation will construct new pavement and make other upgrades to Tongass Avenue, in collaboration with utility replacements by the City of Ketchikan. Tongass Avenue extends from the airport ferry terminal through town to Deermount Street. Traffic volumes average between 7,600 and 18,400 vehicles per day. The total of previous appropriations is not sufficient to fund the construction phase.

Pavement replacement and related upgrades support the Department's mission of improving mobility of people and goods. Rutting is pronounced, with most pavement surfaces dating to 1991. Many sidewalks, drainage structures and light fixtures are older. To minimize delays during construction, scheduling of this project has been deferred until it can be coordinated with utility work.

This project can proceed to construction now that the City of Ketchikan has made final arrangements that fund the local share of utility replacement costs.
