**Brief Summary and Statement of Need:**

This project provides receipt authority for federal and local government funds including federal National Fire Plan allocations to Alaska. Funding provides specific support including the ability of the State and local government to educate, mitigate, prepare for and respond to threats of wildland fire. This authority will allow state direction to cooperative forestry projects in which state, federal and local governments have mutual interest to participate. Projects also include forest health initiatives, insect and disease examination, internships, and community and urban forest inventories; and, local government funding for hazard fuels reduction, fuels treatment, and forest stewardship projects.

**Project Description/Justification:**

Projects funded with these authorities have included fuels mitigation on the Anchorage Hillside and Mat-Su Borough, spruce bark beetle-kill fuels removal on the Kenai Peninsula, hazardous fuels mitigation in the Interior, statewide public fire prevention and education, Type I hotshot crew sponsorship, volunteer fire department grant assistance, and hazard fuels mapping to name a few.

**Detailed Project Justification:** This CIP supports the Department's mission to develop, conserve and enhance natural resources for present and future Alaskans by delivering federally and local funded forest management, development and wildfire preparedness programs. AS 41.17.030 gives management of state forests to the Department of Natural Resources. This CIP will enable the Division to meet specific program requirements with federal and local support, including but not limited to the responsibilities of providing wildland fire protection services on state, private and municipal

lands as mandated in AS41.15.010 – 170. These federal funds will allow the Division to improve and enhance its abilities to support both resources and wildland fire programs that benefit the citizens and resources of Alaska. The threat of catastrophic wildland fires in the urban interface areas in the state is increasing as the citizens of Alaska continue to move into the forested areas of the state and drought conditions persist. Additional federal grant funds may be anticipated to support forest resource management projects that may include:

- Forest resources and management
- Insect and Disease projects
- Urban and Community Forestry
- Forest Stewardship
- Forest Practices
- Forest Land Enhancement
- Forest Resource Inventory
- Cooperative forest resource research projects
- Improvement of the Division’s initial attack and extended attack capabilities.
- Improvement of local government and volunteer fire department capabilities to respond to structure and wildland fire incidents in the urban interface and rural areas of the state.
- Provide funding for EFF type I hotshot crew to be utilized in Alaska and the lower 48 to aid in the suppression of wildland fires.
- Community planning with GIS for wildland fire.
- Fuels mapping for wildland fire.
- Hazardous fuels mitigation projects.
- Prevention and education emphasizing Firewise concepts.
- Forest stewardship planning with private landowners and native corporations
- Provide funding for the development of Community Wildfire Protection Plans

The Project does not directly raise state revenue. However; it expands the state’s effectiveness in both forest management and wildland fire management.

**Why is this Project Needed Now:**

This CIP will provide the Division with needed capacity to support increasing program demands in both forest resources and wildland fire management brought about by increasing public need for services in forest resources (ie. Forest health, etc.), increased risks to public health and safety (ie. Wildland/urban interface education, prevention, & suppression).

**Specific Spending Detail:**

Line Item Detail Description:

Personal Services – Twenty federally-funded initial attack firefighter positions, and extension of seasonal positions to train and test volunteer fire department personnel to fight wildland fires. (Forest Technician II’s, III’s, and IV’s). CIP Receipt funding for emergency or seasonal personnel to perform hazard fuels mitigation work in cooperation with boroughs and municipalities.

Travel – Travel and per diem costs for state and local government personnel to travel to and present and receive specialized and required recurrency training. Travel associated with implementation of National Fire Plan mitigation and educational projects.

Services – Contractual services funding to facilitate intermediate and advanced Incident Command System (ICS) training and specialized fire training; hazardous fuels mitigation by contractors or by rural 16-person crews; sponsorship of an EFF hotshot crew; and other National Fire Plan projects.

Commodities – Miscellaneous supplies associated with the fire and aviation program. Small tools, fuels and vegetation mapping software and supplies, warehouse and logistics supplies, training materials and manuals.

Capital Outlay – Purchase of specialized firefighting equipment for use by the Division's firefighters, local government and volunteer fire departments. Scientific equipment and supplies used by forest health specialists for entomology.

**Project Support:**

Broad support is anticipated from the general public, local government, volunteer fire departments and numerous state and federal government cooperating agencies.

**Project Opposition:**

No opposition is anticipated for this CIP.

**State Match Required:**

Some federal grants have a 50% - 75% state match requirement and some require no state contributions. The match will be met by in-kind contributions and general funds already obligated existing Division's Forest Management & Development and Fire & Aviation programs.
