The FY07 Governor's Budget includes \$150.0 Federal Funds and this amendment adds \$150.0 Federal Funds for a new FY07 project total of \$300.0. Mark overland winter trails in Northern Region with permanent trail markers. Trail markers will ensure winter travelers can safely journey by snowmobile and dogsled between communities in the area. This project contributes to the Department's Mission by reducing injuries, fatalities and property damage and by improving the mobility of people and goods.

FY2005 - \$219,300; FY2004 - \$258,500; FY2003 - \$380,000.

Project Description/Justification:

The purpose of this project is to identify and mark safe and secure travel routes between remote communities without normal highway access. Winter overland travel between these communities is primarily by snowmachine. Changing weather conditions and low visibility due to darkness and storms can cause travelers to become lost or stranded and is a major safety concern.

Establishing well marked routes significantly improves safety for travelers and reduces search and rescue efforts. The need for this project is identified in the Department's Transportation Area Plans and is a priority of the communities. This is a cooperative project involving Northwest Arctic Borough villages, North Slope Borough villages and villages in the Tanana Chiefs region.
