**Project Description/Justification:**

The Mat/Su Borough is the fastest growing area in the State. The current transportation system is discontinuous. A key element to the Mat/Su Borough's Long Range Transportation Plan is to provide an additional east/west and north/south connection. This 3 mile link will allow a northern corridor from the Glenn Highway to Wasilla Fishhook Road. It will reduce the pressure on the Palmer/Wasilla Highway. This project will allow Bogard to become a more effective east/west connector servicing the Palmer/Wasilla Core Area. Connecting Bogard to the Glenn Highway will provide an alternative access into the Palmer commercial business district from the residential mid-Valley area. It will serve to relieve some of the congestion currently experienced at the Glenn Highway/Palmer Wasilla Highway Intersection.
