Project Description/Justification:

Modifications and maintenance of the Kodiak Launch Complex to adequately support the satellite launch program administered by the State of Alaska's - Alaska Aerospace Development Corporation (AADC).

It will allow further infrastructure development at the Kodiak Launch Complex in response to customer needs. This will allow Alaska Aerospace Development Corporation to respond quickly in a dynamic aerospace environment, keep pace of fast developing technology, remain competitive, and expand service. Expanded service creates more jobs and positively affects the local and state economy.

Of the \$38.0 million appropriated in FY2004, \$35.6 million has been obligated/expended. Of the \$36.0 million appropriated in FY2006, \$30.0 million has been obligated/expended. In FY2007 Alaska Aerospace Development Corporation is planning to launch 1-3 satellites. Additional authority is needed in FY2008 to receive and expend the federal funding provided by the U.S. Missile Defense Agency.

State General Fund monies are not required.
