Dear Representative Johnson:

Thank you for your interest in the Anchorage Fire Department (AFD) Station's 7 (Jewel Lake), 15 (Southport) and 9 (Huffman).


The AFD would like to request \$2,000 for each of these fire stations to install Municipal network wifi at the stations to provide better access to download mobile data into fire apparatus.

Creating available storage is always an issue at our fire stations as we acquire new tools and equipment. Station 15 needs \$3,000 for storage improvements. Station 9 has also requested \$20,000 to replace outdated rescue tools and \$3,000 for replacement of fitness equipment.

Fire Station 7 needs \$7,000 for security upgrades. While fire station break-ins are rare in Anchorage, Station 7 has been burglarized twice in the last three years. The burglars have primarily tried to target drug boxes on fire engines, which are secured according to DEA standards behind a very secure two lock system. After the second break in, which occurred at night while firefighters were sleeping between calls, AFD had the Police Department conduct a security audit. The audit recommended a security fence at a minimum along with investigating the possibility of an alarm system. We are also seeking funding to paint the exterior of that station.
