The purpose of the project is to consolidate the department's various investigations systems into one system. Three divisions (Banking and Securities, Corporations, Business and Professional Licensing, Insurance) currently have stand alone investigation systems. These systems are written in older technologies and there is no connection between the systems for cross referencing or joint investigations.

Consolidating the systems will allow for reduced support costs and increased investigation and enforcement efficiencies. It will also allow for tightly integrated investigations in cases that span divisions.

8. What will happen if the project is not approved?

Stand alone investigation systems slow investigations and discourage cooperation between investigation teams. Increased support costs are necessary to maintain systems built in older technologies. Time is wasted in storing files and related documents in various locations. Inability to allow AG's office to view case information realtime.
