The State has been notified by our Congressional delegation of a new interoperable emergency communications grant to states starting in SFY2009 and continuing for a minimum of five years. The intent is to provide funding that will build on the one-time Public Safety Interoperable Communications (PSIC) Grant to ensure implementation of the state's Statewide Communications Interoperability Plan (SCIP). Project Description/Justification:

Improved Communications for Emergency Response (ICER)

The State has been notified by our Congressional delegation of a new interoperable emergency communications grant to states starting in SFY 2009 and continuing for a minimum of five years. We are in receipt of the committee report that outlines the possible appropriation and minimum allocations to states. The intent is to provide funding that will build on the one-time Public Safety Interoperable Communications (PSIC) Grant to ensure implementation of the Statewide Communications Interoperability Plan (SCIP) and thereby improve emergency communications among states, regions, and the nation and in some instances international border communities. The impact of this funding is directly related to the Division's Performance Measure to "Improve emergency response and recovery to disaster and terrorism prediction, threats and events" and will enhance the end result of "Reduced loss of life and property and rapid recovery from terrorism and disaster events."

The Committee Report outlines \$1,600,000,000 over five years, and allocates a minimum to each state with increases for risks and threats. Alaska will likely receive \$3,200,000 per year based on historical risk and threat determinations. The ICER Grant Program will also likely require the same 20% in-kind/soft match of \$800,000 as was required in the PSIC Grant Program.

The ICER Grant will provide for improved statewide emergency communications for which Alaska Land Mobile Radio (ALMR) program is a potential applicant. The requirement of this grant, as with the PSIC Grant, is to supplement efforts underway and not supplant programs currently funded by the State.
