Project Description/Justification:

The program provides funding to develop special needs housing that cannot be funded under AHFC because of statutory limitations. Funding for residential housing that requires a substantial treatment component or that houses individuals who have been remanded by the courts is prohibited under AHFC statutes. These funds will allow for the acquisition, development or rehabilitation of such needed facilities.

Special needs housing includes housing designed to meet the needs of persons with specific and special housing needs, including supportive services. Special needs housing projects under the AHFC grant program must also meet the definition of "residential housing" under AS 18.56.390(12). This definition restricts special needs housing to housing primarily providing dwelling accommodations. The Attorney General's Office has determined that when an ancillary use such as supportive services prevails over the primary purpose of dwelling accommodations, the facility ceases to be considered residential housing. The definition of "residential housing" also takes into account whether the occupants are free to come and go as they choose. If a person is compelled by law to remain at a certain facility, this level of compulsion and confinement often does not meet the statutory definition of "residential housing".

Because of the restrictive nature that the definition of residential housing places on the Special Needs Housing program

with AHFC, many agencies that serve Trust beneficiaries do not qualify for funding under the AHFC program. The Department of Health and Social Services is not constrained by this definition and would be able to fund programs in which treatment is an integral part of the housing accommodation, or where residents are legally compelled to reside at a facility.
