1 * **Sec. 6.** PURPOSE. In accordance with AS 37.14.003 and 37.14.005, the appropriations
2 made by this Act are for the state's integrated comprehensive mental health program.

3 * **Sec. 7.** ENTERPRISE INFORMATION TECHNOLOGY PROJECTS. (a) The sum of
4 \$459,724 is appropriated to the Office of the Governor from the following source in the
5 amount stated and allocated for the Department of Health and Social Services information
6 technology security project:

12 (b) The distribution to the Department of Health and Social Services of the
13 appropriation allocated in (a) of this section is contingent on the Department of Health and
14 Social Services signing an agreement to participate in the Department of Administration's
15 enterprise collaboration model for information technology projects.

16 * **Sec. 8.** NONGENERAL FUND RECEIPTS. (a) Alaska Mental Health Trust Authority
17 authorized receipts (AS 37.14.036) or administration receipts (AS 37.14.036) that exceed the
18 amounts appropriated by this Act are appropriated conditioned upon compliance with the
19 program review provisions of AS 37.07.080(h).

20 (b) If Alaska Mental Health Trust Authority authorized receipts (AS 37.14.036) or
21 administration receipts (AS 37.14.036) fall short of the estimates appropriated in this Act, the
22 affected appropriation is reduced by the amount of the shortfall in receipts.

23 * **Sec. 9.** SALARY AND BENEFIT ADJUSTMENTS. (a) The appropriations made in sec.
24 1 of this Act include amounts for salary and benefit adjustments for public officials, officers,
25 and employees of the executive branch, Alaska Court System employees, employees of the
26 legislature, and legislators and to implement the terms for the fiscal year ending June 30,
27 2010, of the following ongoing collective bargaining agreements:

- 28 (1) Alaska Public Employees Association, for the confidential unit;
- 29 (2) Alaska State Employees Association, for the general government unit;
- 30 (3) Alaska Public Employees Association, for the supervisory unit;
- 31 (4) Alaska Vocational Technical Center Teachers' Association - National

1 Education Association, for the employees of the Alaska Vocational Technical Center;

2 (5) Public Safety Employees Association, representing the regularly
3 commissioned public safety officers unit.

4 (b) The operating budget appropriations made to the University of Alaska in this Act
5 include amounts for salary and benefit adjustments for the fiscal year ending June 30, 2010,
6 for university employees who are not members of a collective bargaining unit and for
7 implementing the monetary terms of the collective bargaining agreements including the terms
8 of the agreement providing for the health benefit plan for university employees represented by
9 the following entities:

10 (1) Alaska Higher Education Crafts and Trades Employees;

11 (2) University of Alaska Federation of Teachers;

12 (3) United Academics;

13 (4) United Academics-Adjuncts.

14 (c) If a collective bargaining agreement listed in (b) of this section is not ratified by
15 the membership of the respective collective bargaining unit, the appropriations made by this
16 Act that are applicable to that collective bargaining unit's agreement are reduced
17 proportionately by the amount for that collective bargaining agreement, and the corresponding
18 funding source amounts are reduced accordingly.

19 (d) Appropriations made in sec. 1 of this Act for salary and benefit adjustments as
20 described in (a) and (b) of this section are for the benefit of the state's integrated
21 comprehensive mental health program only and do not necessarily affect every group of
22 noncovered employees or every collective bargaining unit listed in (a) and (b) of this section.

23 * **Sec. 10.** LAPSE. The appropriation made by sec. 7 of this Act is for a capital project and
24 lapses under AS 37.25.020.

25 * **Sec. 11.** This Act takes effect July 1, 2009.
