**Brief Summary and Statement of Need:**

Additional funding is being requested to continue work on the Foothills West Transportation Access EIS due to scoping comments received by United States Army Corps of Engineers (USACE) that included the addition of an evaluation of a route from Umiat to the existing industry roads on the North Slope. To analyze this route, evaluations will include environmental studies, engineering baseline studies, subsistence and cultural studies, hydrology evaluations, geotechnical evaluations and imagery. Preliminary engineering and environmental work will be completed in order to produce an environmental impact statement (EIS) and to permit the selected route.
