Brief Summary and Statement of Need:

This project provides renewal, replacement, renovation, remodeling and repair of essential electrical, mechanical, roofing, walls, fire and life safety, security, structural, food service, pavements, and site drainage systems within the Combined Hiland Mountain Correctional Center. This work is required to enable continued secure and efficient operation of this 24-hour incarceration facility in order to keep the community safe from offenders placed in the department's custody.

Project Description/Justification:

The Hiland Mountain Correction Center (HMCC) was constructed in 1973 and includes 145,000 square feet of space. This project provides telephone replacement (\$125,000) and central heating equipment in the kitchen and education buildings (\$80,000) at the HMCC.

This project is a compilation of essential capital maintenance requirements at this institution. The list is fluid between the time the Governor's budget is submitted and the time the appropriation is authorized. During this time period, other critical projects may be identified while several projects already on the list have reached completion. Funds are then allocated to the most urgent of the remaining projects. The projects not completed become the basis of the next fiscal year capital appropriation request. Adjustments to the deferred maintenance project allocations may be necessary between all 24-hour institutional facilities to meet emergency needs as they arise.
