The contract, approved by the UA Board of Regents, includes the following: grid adjustments in FY2016 2%, FY2017 2%, and FY2018 2%; a \$900 lump sum payment (not to base) for eligible members each year of the contract, coincident with the annual salary increase; and an increase of .5% of base for market adjustments in FY2017 only. This item accounts for the base adjustment only.

There is an error in the salary amounts included for student employees. This amount was inadvertently included twice in the Governors budget. The overall salary increase should be \$18,637.6 (\$9,318.8 UGF and \$9,318.8 University Receipts). This salary adjustment corrects the error.

The contract, approved by the UA Board of Regents, includes the following: grid adjustments in FY2016 2%, FY2017 2%, and FY2018 2%; a \$900 lump sum payment (not to base) for eligible members each year of the contract, coincident with the annual salary increase; and an increase of .5% of base for market adjustments in FY2017 only. This item accounts for the lump sum portion (not to base) only.

Funding for the increased cost of University of Alaska employee benefits. University of Alaska employee benefits are comprised primarily of employer retirement plan contributions (PERS, TRS, ORP and Pension Plan) and employee healthcare costs paid by the University of Alaska. Better than expected healthcare claims activity in prior years created credits that helped off-set projected future healthcare claim costs, thus lowering the benefit rates. As of FY2016 the credits have been fully applied, thus the benefit rates are projected to increase for most employee groups in FY2017.
